Notice is hereby given that the **Carrier Sekani Tribal Council** has called a Nomination Period **March 16- 26, 2022** in accordance with the *Election Process for Tribal Chief, 2017* for the purpose of Eligible Voter's nominating one (1) candidate for the Office of Tribal Chief on **30 April, 2022**, for the ensuing term of office.

## NOTICE OF NOMINATION PERIOD MARCH 16-26, 2022

### IMPORTANT INFORMATION

Voters eighteen (18) years of age and older as of the date of the Election who are registered as Members of Wet'suwet'en First Nation, Burns Lake Band, Stelat'en First Nations, Nadleh Whu'ten Band, Saik'uz First Nations, Tl'azt'en Nation; may nominate or second, and Vote in this Election, and shall form the Voters List.

Nominees must meet the following criteria by 12:00AM on the fifth calendar day after the Nomination Period Closes (March 26th, 2022) in order to stand as a candidate for office:

- a) Candidates fee in the amount of \$250 payable to the Chief Electoral Officer by cheque, money order or cash;
- b) A Criminal Record Check (See Appendix 4 of the *Election Process, 2017*);
- c) Must complete an Acceptance Form;
- d) Confirmation in writing from their band that the Candidate is not in arrears with respect to any financial obligations.
